1. Point no. VI – Share holding Pattern

In Point no. VI(C) - Disclosure of Foreign Portfolio Investor (FPI) Shareholding
In the MGT-7 form, under the section relating to **Foreign Institutional Investors**, the system did not allow us to proceed while entering the shareholding details of **Foreign Portfolio Investors (FPIs)**. The FPIs collectively hold **7 shares**, which represents **0.0000552% of the total shareholding**.

However, the e-form validation permits entry only up to **two decimal places**. Entering the said value as **0.00%** did not validate and resulted in an error, preventing submission of the form.

Accordingly, in order to complete the filing process within the system constraints, we have disclosed the FPI shareholding under the **“Others”** category.

Further, the Date of Incorporation of FII is not available, hence we have mentioned dummy date in the form. **The List of FII is attached with the form as an attachment.**

This clarification is being provided to ensure transparency and to confirm that there is no misstatement of the actual shareholding.

2. Break-up of Total Shareholders

As on March 31, 2025, the total number of shareholders stood at **1,570**. Out of these, details of **484 shareholders** were not provided by the depositories in terms of gender-wise breakup.
